Determination of compensation for the Mayor and Aldermen

The Municipal Council decided unanimously to fix at EUR 118,80 (OR = 100) the monthly allowance accruing to the Mayor of the Commune of Weiler-la-Tour, adaptable on the 1st of each month to match variations in the sliding pay scale using the application rate in force on that date

The Municipal Council decided unanimously to fix at EUR 59,40 (OR = 100) the monthly allowance for each Member of Weiler-la-Tour, adaptable on the 1st of each month to match variations in the sliding pay scale using the application rate in force at that date.

The Municipal Council decided unanimously to set the entry into force of compensation as the date of entry into service of members of the College of the Mayor and Aldermen.

Establishment of local members' attendance fees

The Municipal Council unanimously decided to fix at EUR 9,54 (OR = 100) per meeting the attendance fee to be allocated for local members attending the Municipal Council meetings.

Art. 2/5/1. Maximum allowed speed

On the listed routes the maximum authorised speed, at designated places, shall be limited to the indicated speed. This shall be indicated by adapting sign C, 14 'speed limit".

Art. 2/1/1. Access prohibited

For the routes set out below/attached and referring to this Article, access to the sections designated shall be prohibited for drivers of vehicles and animals in the direction indicated. Those sections shall be accessible in the opposite direction.

This arrangement shall be indicated dor the prohibited direction by sign C, 1a 'no entry', and, in the opposite direction, by sign E, 13a or E 13b 'one-way'.
